- ENTRY FEE:** \$8.00 Pre-registration. Postmark by 5/13/09 (T-shirts extra)
- RUNNERS/WALKERS:** \$10.00 Race Day registration (entry fee does not include t-shirt)
- T-SHIRTS:** \$8.00 (entry fee does not include t-shirt)
- RACE DIVISIONS:** Run Divisions: 11 & under, 12-15, 16-19, 20-29, 30-39, 40-49, 50-59, 60-65, 66-69, 70
Walk Divisions: 29 and under, 30-39, 40-49, 50-59, 60-69, 70 and over
- AWARDS:** Top 3 runners and walkers in all male & female race divisions. Male & female overall top runners and walkers.
Armed Forces Day "5K Run/Walk" Military Cup award: for overall top runner representing their unit.
- COURSE:** Starts at the corner of Rosewood and Buttermilk, Rosewood to Squire Oak, left on Squire Oak, left on Palomino, right on Woodchuck, left on Northcutt, loop then reverse course and end at the corner of Rosewood and Buttermilk.
